Additional community outreach programs include food box distribution to the elderly and disabled, distribution of diapers, wipes and baby food to needy mothers, distribution of hygiene kits to the homeless, a Christmas assistance program for the needy and administering a daycare in conjunction with DFACS.

The Mission provides a residential program for female victims of domestic violence and their children by providing a safe place where women can find healing and regain independence. The goal with this six-month program is to empower the women to become self-sufficient by gaining self-esteem, life skills, and Biblical knowledge and they are taught to recognize the cycle of violence.
